

CPNI Protective Security Self-Assessment Checklist

Our colleagues within the Centre for the Protection of National Infrastructure (CPNI) have published a protective security self-assessment checklist for businesses to use during a pandemic.

This new guidance is based on their existing, much larger product called Protective Security Management Systems (PSeMS).

This version is 15 essential security questions relating to the current crisis. It has been designed for the industries and businesses who perhaps did not previously engage with CPNI, but have suddenly become critical to the UK and may need to review their security posture. However, this version could be of interest to anyone who may be considering what they need to do in order to secure their business in the current climate.

This document is designed to assist an organisation in understanding its strengths and weaknesses with respect to organisational security assurance during a Pandemic such as COVID-19.

The assessment includes the most important and critical elements of a PSeMS and is a good starting place, especially for organisations that are less familiar with respect to PSeMS.

Who should complete the assessment?

Security managers responsible for the organisation's security in consultation with organisational stakeholders who directly or indirectly impact security.

The initial assessment should be reviewed and validated with senior management.

How to use the document.

This document contains a number of indicators of good practice (statements) which are particularly relevant to managing protective security during a Pandemic. Those responsible for security should use these to assess their current status and record any required actions.
